Caveat Emptor [Latin, Let the buyer beware.] A warning that notifies a buyer that the goods he or she is buying are "as is," or subject to all defects. When a sale is subject to this warning the purchaser assumes the risk that the product might be either defective or unsuitable to his or her needs. This rule is not designed to shield sellers who engage in Fraud or bad faith dealing by making ...

"Caveat emptor does not mean either in law or in Latin that the buyer must take chances. It means that the buyer must beware." On the other hand, Caveat Venditor is a rule, transmitting the accountability for defects or deficiencies upon the supplier of goods, and conveying the exact contrary of the common law rule of Caveat Emptor.
